



BUILDING THE FUTURE DEPOSITARY MODEL

We have embarked on an ambitious programme to deploy new technologies, such as Artificial Intelligence and Machine Learning, into the heart of our depositary processes. With the support of BNP Paribas's leading edge digital think-tank and incubator, we launched a global search for a 'reg-tech' that had developed disruptive technologies relevant to our industry.

We chose to partner with Fortia Financial Solutions, who has developed impressive time-saving technology, using Artificial Intelligence to automatically scan a fund's constitutive documents (e.g. prospectus) and then capture and parse the investment compliance restrictions contained within. An algorithm then

analyses the syntax and uses smart mapping to suggest controls to be automatically created in the compliance monitoring system.

This technology is helping us to build the next generation depositary platform that is without comparison in the industry today. It will enable us to work more efficiently, reduce risk and further improve our ability to provide services at the level expected by our clients and regulators. At the same time, we are re-creating our service model in such a way that the client experience will be efficient but also engaging – whichever means of communication our clients prefer.
